- 1) **Proposed amendments** to the Constitution and By-Laws may be submitted on the Proposed Amendment Submission Form by fax (519-474-3664), email (etfotvtl@etfothamesvalley.com), sent in mailbag (send by February 10, 2025), or dropped off in-person. An additional copy of the form may be downloaded from the Local's website. Proposed amendments must be received by the ETFO Thames Valley Teacher Local office **by 4:00 p.m., Monday, March 3, 2025.**
- 2) **Any active Member** may submit a proposed amendment.
- 3) All proposed amendments will be distributed to the membership by the week of April 1, 2025.
- 4) The proposed amendments will be voted on by all Members who attend the ETFO Thames Valley Teacher Local Annual Meeting on Wednesday, April 23, 2025.
- 5) **The mover and seconder** of a proposed amendment **must be present** at the ETFO Thames Valley Teacher Local Annual Meeting on Wednesday, April 23, 2025 to put forward their amendment.
- 6) For Constitutional amendments, a quorum of the Local Annual Meeting must be present.
- 7) Sixty percent (60%) of the Members present at the Local Annual Meeting are required to vote in favour of an amendment for it to pass.
