# VICE PRESIDENT'S REPORT - Scott Hardie

### 1.0 **Staffing**

- The Board delayed the timeline for fall reorganization. Concerns about the impact of this
  delay on learning were shared with the Board. Registration is up across the Board and
  staffing last spring had classes populated near the maximum allowance. The result was
  a significant reorganization in many school sites. Reorganization affected most schools
  this year.
- Contract Teacher positions were filled. All remaining positions were filled with LTOs for the remainder of the year. This process was completed the end of October. Members were encouraged to review their supervision and prep minutes of their timetable.
- The Reorganization Staffing Committee is comprised of members from HR, Senior Administration and ETFO Thames Valley Local Officers. The committee oversees the staffing decisions related to school openings, closings and boundary changes. The committee held its first meeting on October 28. The procedures of the Reorganization Staffing Committee are highly structured and uphold the staffing procedures set forth in the Collective Agreement. The committee met with Workplace Stewards and Principals of schools affected by school closures, openings and boundary changes in early January to introduce the process. Late January/early February the committee hosted meetings with affected school staffs to work towards making the process equitable and transparent. The process followed the agreed upon timeframe. All Members received an assignment within the reorganization prior to spring staffing. Members in the reorganization were still able to access the staffing rounds.
- The addition of numerous acting Vice-Principals mid-year, required a meeting with HR to review the staffing process. These positions will be filled with an OT for the remainder of this year and the second partial year of the acting position, so the acting member may return to their position if they choose.
- Discussions at District Staffing proposed a model of reviewing historic kindergarten average allocations at a school site prior to decreasing the school's kindergarten allocation in the spring. There are many schools that regularly have decreased a kindergarten classroom, due to a lack of spring enrolment, only to have the position reallocated in September. This proposal would help to minimize fall reorganizations. Human Resources is presently reviewing the idea.
- LLI is a reading program. It is not a teaching assignment. Any timetabling of LLI as a timetabled assignment should be reported to the Local.
- Unfilled Assignments The School Board is facing a problem that there are no applicants
  to recent open teaching positions. This leaves classrooms without permanent Teachers
  and teaching specialist staffs' responsibilities being unattended to. The Local has
  approached the Board requesting information about the scope of this problem and their
  plan to address it. These talks are ongoing. ETFO Members should not be coerced into
  completing work beyond their assignment.
- Present teaching allocations to schools have resulted in classrooms having student distribution at, or even over, Collective Agreement classroom caps. The Board has stated that this is the result of all virtual students being counted at their in-person home school. Prior to Round 1, virtual classrooms were created based on the requests from parents. Early indications show demand for virtual learning is dropping. Once students are placed into virtual assignments, the Board will review all schools' student numbers and provide additional allocations where required. We will monitor this process to ensure classroom staffing numbers are not in violation.

## 1.0 **Staffing** – continued...

- Each year there are schools within our Local that have a large number of our Members transfer out during the staffing rounds. The school Board has been encouraged to review the reasons for these moves. From our perspective, there a few explainable situations, like the retirement of a popular Principal, but most schools, with a large number of Members leaving, are the same locations that there are high number of violent incidents and lack of Administrative support. Supported, valued Teachers move much less often.
- We have followed up with the school Board on concerns of some Principals being unprofessional during interviews. Principals telling candidates that they have someone in mind at the onset of the interview or refusing to give feedback are a couple of examples of the unprofessionalism our Members faced during interviews this year.
- Teachers who are required to move classrooms have two days available to pack, unpack
  and set up their classroom (L17.17). These must be used before the end of the school
  year and cannot happen on the final PD Day. Moving days are covered by an OT.
  Members need to request the days required from the Principal. Any denial of a moving
  day needs to be reported to the Local immediately.

## 3.0 Virtual Classroom Assignments

- Some school sites have provided inadequate classroom arrangements for virtual Teachers. The virtual Teacher's space is their classroom. Virtual Teachers require a teaching space to be in a permanent location, have adequate ventilation and privacy. Virtual Teachers with concerns should contact the Local.
- The Ministry of Education has announced that school Boards must provide some option for virtual learning next school year. The Local is advocating that the program's parameters must be limited in scope and in place prior to spring staffing. The Local's goal is to avoid the interruptions in staffing experienced during the past couple of years.
- Virtual classrooms will first be staffed with Teachers whose medical accommodations require a virtual assignment. Remaining positions will be posted in Round 1. A move to a virtual classroom is a move to the school the virtual classroom is located in. When virtual classrooms end, they will be absorbed into the staff compliment. This process will result in some surplus staff being offered recall to their school.
- There is much confusion regarding the Collective Agreement language and its application to Teachers who are partially surplus. Human Resources acknowledged this concern, suggested it be a topic for Workplace Steward-Principal Training and committed to clarify communications to Principals next year.
- The Board has 2 Principals conducting interviews for Teachers who apply to transfers in the staffing rounds. An Acting Vice-Principal may not be part of an interview; even as an observer. They are ETFO Members and may not evaluate other ETFO Members. Interviews this school year are to be either virtual or in-person, but the model selected was to be consistent for all Members interviewing. There were some concerns raised about unprofessional comments said during the interview process. Most concerns involved beginning the interview stating they already had another candidate in mind. This is unacceptable in a professional setting and has been shared with Human Resources.

## 3.0 Progress Reports

- The TWEA program was not operational the first week of October. Some schools gained
  access before others. The final schools gained assess the week of October 16.
   Members unable to make the deadline for report submission were to notify their Principal
  that they will be delayed, as a result of the Board's delay.
- The progress report is a brief observational report based on the student's progress of the grade level curriculum expectations. These expectations are presented in Growing Success and these expectations cannot be modified because of the learning model the students worked in last year. Students absent from learning will have blanks on their progress reports.

#### 4.0 Attendance

• The Local office received many calls regarding absent students and Principal requests for work and/or investigative calls to the student's home. The Education Act sets the responsibility of absent students with the Principal. Chronic absences are investigated by attendance counselors. There is no expectation that busy work be provided for absent students. Teachers are responsible for submitting daily attendance and teaching students who are present in the classroom. The office deals with students who are absent.

#### 5.0 Low German Focus Sites

• The Local Officers met with Senior Administration to review the Trustee approved plan to offer Summers' Corners P.S. and Straffordville P.S. as school locations to encourage Low German students to attend. The plans presented were vague, but the schools will have a room in which the students may go to and recite the Lord's Prayer (a traditional Christian prayer) and students may opt out of parts of the health curriculum. The Local ensured positions would belong to ETFO Members, that the Ontario Curriculum would be followed, that the values of equity and diversity would be promoted and that the PRIDE flag would continue to be flown at the schools. The Local continues to monitor the implementation of this program.

#### 6.0 Student Masking

The current practice of addressing a student mask concern is the Principal forwards the
concern to the area Superintendent for review. The Board's Health and Safety
Manager's involvement in these situations is inconsistent. There are cases of mesh
masks and see-through silk masks being approved for students. We have requested a
minimum standard for student masks be established. Teachers are reminded that all
student masking concerns or protocol violations must be reported to the Principal.

# VICE PRESIDENT'S REPORT – Glenda Manzi

# 1.0 Teacher Performance Appraisal (TPA)

#### October 2021

➤ Teachers in virtual assignments were to be evaluated by the Principal of the building from which they were teaching. Teachers in virtual assignments and teaching remotely were to be evaluated by the Principal of the school to which they were assigned.

#### November 2021

➤ There is no longer a "pause" on TPAs but the Ministry has provided guidance to Boards on how to schedule TPAs for this year and the coming years to catch up from last year's pause. The direction provided was that staff who were scheduled to be evaluated last year and were not, will be evaluated this year. Those scheduled for this year will be bumped to next year and so on.

#### December 2021

- ➤ The Board is in the process of reviewing and rewriting the 63-page document called Procedures for the Supervision of Teaching Staff. ETFO was not invited to provide input.
- ➤ A memo sent to Administration acknowledging Administrator and Staff workload. The memo suggested the following criteria for the completion of TPAs:
  - Continue all TPAs in progress at the present time.
  - Continue all TPAs where concerns have been identified.
  - All NTIP (New Teacher Induction Program) contract appraisals will continue as planned to allow these individuals to move from probationary to permanent.
  - Where possible, continue all TPAS wherein there is mutual consent.
  - There will be a pause on all other TPAs for this year.

> No TPAs should begin after May 31.

> NTIP Professional Development modules were cancelled for October due to insufficient OT coverage.
