Subject: Cyber Awareness Resources

As part of the 2023-24 Cyber Protection Strategy initiative, the ministry is committed to developing and sharing flexible resources to support a collaborative approach between the ministry and school boards/authorities (boards) – to improve cyber awareness in boards in the areas of cyber security, protection of privacy and online safety. This year, resources are again available to all school boards and authorities as described below.

Cyber Awareness Calendar

To support a year-round approach on improving online safety, protection of privacy, and cyber security, a cyber awareness calendar is available with monthly themes and monthly information sheets to provide further information on each theme and best practice considerations. These documents can be used online or printed for use in learning and office spaces.

New this year, an interactive calendar is also available with curated information about different cyber-related events occurring throughout the year, some of which may be coordinated by industry or different organizations. Some boards may wish to learn more about these events and determine their own level of participation.

Cyber Awareness Month (CAM)

Resources to support the annual K-12 Cyber Awareness Month (K-12 CAM) in October 2023 – have been developed in partnership with school boards, the Educational Computing Network of Ontario (ECNO), the government's Cyber Security Division, and various ministry stakeholders. Each week in October will feature a different cyber focus, with custom videos, posters, games, and links to curated resources from reputable sources, made available to all boards.

New this year, a K-12 Zone was developed by the government's Cyber Security Division in partnership with the ministry, boards and other stakeholders. The K-12 Zone features cyber security games, articles, videos and quizzes and will also be available to all boards throughout the year. Additionally, the annual Ontario Public Service (OPS) CAM campaign will be launching on October 3, 2023, with additional resources for teachers and board staff. Participants of Ontario's CAM campaign will gain access to new weekly content, which includes exciting games, interactive articles and videos on cyber security topics such as online privacy and password safety.

The K-12 CAM campaign is a modified version of the internationally recognized Cyber Security Awareness Month campaign, tailored for the needs of the Ontario K-12 education environment.

As these and other resources become available online for the K-12 CAM, cyber awareness calendar, K-12 Zone, and the OPS CAM, we encourage you to share the resources within your board and continue to advocate for greater awareness of good cyber security, cyber safety and online privacy practices to help reduce cyber risk – helping to keep our students, educators, schools and school boards better protected online.

Information in these resources has been targeted to a range of audiences: students, parents, and educators. Your feedback on how we might continue to improve the quality of cyber awareness resources is welcomed.
