James Todd*	"Dealing with closures due to empty pupil places needs to be balanced with renewal of programming, especially at the secondary level. We must ensure that all four pathways are fully programmed in every secondary school so that students can get the education they choose at their home school. The consultation process needs to be adjusted so that parents and the community at large feels heard rather than only experiencing a one-way communication. "	"I fully support a One Public System. I believe there is plenty of opportunity in a well-designed new system for spiritual education, not only for Catholics but other faith communities such as the Hindu and Muslim traditions. All faiths should readily be accommodated inside a single system."	"I am deeply concerned about the occurance of violent incidents in the classroom: it traumatizes students and teachers and puts them at risk. Improving reporting procedures to simplify and streamline it would be welcome, but of even more concern to me is having adequate staffing to allow the offender to be quickly removed from the classroom so that the remaining students are not subjected to the violent behaviour. I am also concerned about the safety risks to teachers having to face violent students. Further training may help, but the emphasis must be on allowing teachers to teach and students to learn."

James Todd*	"I believe that we must fund and program for wellness of students as well as the education of students. I continue to support the realignment of existing resources for safe and inclusive schools, and gladly voted in support of additional funding for mental health initiatives."	"I believe teachers should be allowed to teach, and not be burdened with additional duties that are not essentially educational in nature. The privatization of non-classroom services such as custodial, maintenance or perhaps lunchroom supervision seems to be a reasonable way to manage growing costs. I believe in a public system and would resist privatizing any educational functions."	"I believe that school should be safe, nurturing places for the whole student, and that the learning must keep pace with the fundamental changes we see in society. My aim is to steward the resources we receive to ensure these two things. In the past four years, I have advocated for closely tying together the Board's strategic plans with its budget, and have made great strides in this arena. Next, I advocated for an improved strategic plan that set challenging goals for better schools and better learning. A second dimension that motivates me is making serious improvements to secondary school programming to ensure all four pathways are available to every student at every secondary school. Another area I am keen to

			pursue is to support and encourage the attention paid to literacy in schools. The provincial focus on mathematics and numeracy is worthwhile, but I fear we have not put appropriate emphasis on literacy, and I want to do what I can to see this change. Finally, I want to support the early efforts to help students learn the Global Skills (creativity, critical thinking, collaboration, communication, citizenship, self-management)."

"It is my understanding that education in a Catholic school is a right constitutionally guaranteed to members of that church. I would not presume to infringe upon that right without the express consent and agreement of the Catholic community. If it were possible to amiably establish one system, the potential advantages are substantial, but the pitfalls are equally great. It has been my experience with previous amalgamations that the expected efficiencies are never realized. As a former teacher with the Elgin County School Board, I anticipated a reduction in board supervisory and support employees after the move to TVDSB. I stand to be corrected, but I do not believe this to be the case. It should be realized that any savings from such a move will likely come in the form of teaching staff reduction. This is regrettable, but unavoidable I believe. One Public System would require a revisitation of school board structures."	"If a violent incident happens, the matter should be dealt with immediately. (This is not always currently the case.) The individual involved should be excluded from contact with other students/teachers until the matter is resolved. The teacher/board employee responsible shall provide an account (preferably written) of the incident as soon as possible. The administrator involved shall review the employee report, the student account and any other evidence (such as the student's OSR) before imposing consequences. Those shall take effect immediately. If the matter is undisputed, a report outlining incident and consequences will be included in the student's OSR forthwith. If there is evidence of a criminal offence, the police will be contacted. All the board employees likely to contact the student should be notified as soon as possible. Before the student returns to school a plan must be formulated outlining the nature of past events, a forecast of future behaviour and actions known to trigger unacceptable behaviour. Before returning, the student will take responsibility for their actions and undertake to refrain from future unacceptable behaviour. If the student is unwilling to provide those assurances, they shall be excluded from the regular school body. It is important to note that there must still be some allowance made for the student's education, regardless of their attitude or behaviour."

Peter Rocchus	"The consequences of poor mental health extend to all areas of a person's life. Therefore, any initiatives to help individuals cope in an educational setting must support and be supported by actions in the rest of society. By itself, the education system can do little of value. Having said that, I believe that student mental health can be best supported by advocating for the right of teachers to support their students. Many forms of mental illness prevent the student from doing their best because they are unable to focus on school work. The teacher may be able to devise alternate ways and means to assess the student, but their efforts are hampered by board wide policies on late submissions and standard evaluation. I believe that supporting teachers will ensure that students will be well supported. Classroom teachers see changes in behaviour which can signal declining mental health. Because of the bonds that they form with their students, teacher's concerns and offers of help are often more readily accepted. In short, the best people to look out for student needs are already on the job. The best thing that I or anyone can do is let them work without distraction."	"From my present point of view, there is no place for privatization in education or any other public endeavour. By definition, a private corporation seeks profit. That profit is money diverted from the education system. While private companies promise facilities/services for less, they seem to deliver less for more cost. It seems to be the case that whenever privatization is implemented, wages drop and working conditions decline. Privatization in education should not be considered."	"It is my intent as a candidate to promote more accountability on the part of the school board. Recent board decisions fly in the face of the public's thoughtful wishes. Even after the board was given a way to save face, they have maintained their plan. If possible, I would also hope to see greater autonomy for teachers in their classrooms and increased freedom for principals to manage their schools. I have seen both curtailed with disappointing results. This needs to change. Since no one else is offering to even try, I will."

Bruce Smith	"There is no magic answer to this problem. It is also not a new issue. The student I taught with the greatest need in this area, I taught in 1975 and 1976. My wife has spent her career as an RN on hospital mental health wards and my son is the manager of the Talbot Teen Centre in St. Thomas. We are very aware of the challenges and the growing needs. School staff and students must be made aware of the resources available to them such as the Talbot Teen Centre, Oxford-Elgin Child and Youth Counselling Centre, and Reach Out 24/7. I am also a strong advocate for "Bridges out of Poverty" and would like to promote an awareness of its strategies and goals it as a proactive measure to improve family and children's lives within our system."	"I feel that privatization within the system will lead to inequities and the inability to guarantee that the best possible programing is being delivered. I do not want privatization anywhere near the classroom. Attempts at privatization within the system involving maintenance and cafeteria staff were also problematic."	"First and foremost, my grandchildren are now entering the system and growing up in very different times. Their education, along with their peers, must reflect and prepare them to thrive in a global environment. Second, I have a great amount of experience teaching students from JK through to Masters students at the Don Wright Faculty of Music and teacher candidates at the Faculty of Education. I have Principal Qualifications. 15 years as a high school teacher and 18 years in the elementary system. At the university level I directed jazz ensembles at the Faculty of Music for 8 years and taught teacher candidates how to teach jazz one year at Althouse. Besides many years teaching music I spent three years as a Grade 6 classroom teacher. I think I have a lot to offer a board of trustees many of whom actually have very little experience in education other than they were once students. Third, I witnessed the closing and repurposing of several schools recently and I was disappointed by the management of the process. The

			enormous difference between rural and urban communities with regards to values, practices and needs seemed to be ignored. Our trustee largely went AWOL, said very little, and did not even attend all of the public meetings. This will not be the case if I am involved. Fourth, there are inequities in the education provided to our children across the TVDSB which need to be eliminated. As your trustee I will work to see that every child receives the best we can provide. Fifth, using the excuse of provincial funding formulas to support decisions that seem to put kids and families second is not acceptable. As your trustee I will challenge and change this practice. Lastly, I want to be the advocate for the people in the game who have their sticks on the ice so to speak, the students, the parents, and the teachers. These people are our first and foremost priority. They need to feel valued and completely supported in their work."
