**Subject:** Readiness to Move to Remote Learning

Thank you for the work you and your teams have undertaken to implement daily reporting and for your collaboration with local public health and responsiveness to COVID-19 cases in schools. We are continuing to work closely with the Ministry of Health to monitor cases across the province.

Recent experience with school closures due to outbreaks has demonstrated the critical importance of schools being ready to pivot to remote learning quickly, and we have seen clear cases where this transition has been seamless and effective.

Staff, students, and families should be aware of the school board's remote learning plan and the steps that will be taken should the need arise to move to remote learning in the event of classroom, school, or board closure.

### **Remote Learning Policies**

In August 2020, the ministry released Policy/Program Memorandum No. 164 (PPM 164) to outline remote learning requirements, including synchronous learning, during times of extended interruption to in-person learning. PPM 164 is intended to support boards with minimum requirements and effective practices for remote learning, and ensures a consistent expectation that students and parents can rely on.

To be prepared for a potential closure, school boards should have plans in place so they can move to remote learning quickly. While these plans are overwhelmingly in place, it is the ministry's expectation that all boards are prepared to immediately transition cohorts or schools (based on the nature of the isolation) from in-person instruction to remote learning, with teacher-led instruction resuming within 24 hours of the cohort or school-wide isolation. The continuity of learning is paramount to provide stability and consistency in the lives of our students. The ministry has developed a checklist to support boards in their planning and help inform the ministry of areas where additional guidance and support may be needed.

### **Supports for Educators**

Last spring, 30,000 educators took advantage of the opportunity for training on remote learning. In addition, at the start of this school year, all educators were trained as part of mandatory professional activity days. To further support teachers to prepare for remote learning, the ministry has developed a self-assessment readiness tool for teachers that includes suggested strategies and links to resources.

This tool for teachers and other professional learning resources are available through the ministry's Virtual Learning Environment (VLE). School board staff have access to this space by logging into the VLE and clicking the Supports for Virtual Learning link on their school board's home page. The ministry is also hosting a series of webinars focused on remote learning in the coming weeks and months.
