That being said, here are my thoughts on how the school closure issue should be handled or managed: 1) review the plan that TVDSB trustees had previously made 2)consult with identified schools to see what issues they are having that may factor into school closures/amalgamations etc. 3) make a revised plan for school closures that takes into consideration community feedback and factors in the impact that closing schools will have beyond the financial impact. 4) share the revised plan with communities for feedback and to explain the process 5)ensure that if school closures are necessary, there is lots of communication with parents and that the school is celebrated and honored."	"I find the idea of One Public System to be very interesting, but something that needs to be explored in much greater detail. I would support an all political party task force to examine the feasibility of this proposal. I would also stress the importance of meaningful community consultation. I believe that having one system could greatly reduce the costs of administration and other duplicate expenses – thus leaving more resources to improve the experience for students, and the working conditions for teachers and support staff. However, I would want to hear all arguments and see what a task force recommends."	"This is a very important concern. When a violent incident has occurred (sexual assault, physical assault, possession of a weapon, hate-based occurrence etc.), it is paramount that the student who is reporting is believed and treated with compassion and dignity. In order to ensure this, I believe that ALL school personnel should receive training on responding to disclosures, and how to document a disclosure. All disclosures should be documented, although the identity of the victim should be kept confidential unless they say otherwise. The victim should be offered counselling through the school, and other accommodations as needed (modified course work if they need to take time off school, etc.). A policy should be in place to help determine the best course of action for the accused student. All decisions should be documented, as well as all contacts with the victim and the accused."
