In my opinion, there are two main points to be considered and those considerations would be priorities in all decisions I would make as a TVDSB trustee: SAFETY: a major concern for students, teachers and other staff members. We must consider if the physical characteristics of the school are suboptimal for safety, and other considerations such as potential asbestos removal, heating/cooling etc. These of course will have a significant impact on budgets as we bring the school up to the acceptable, optimum standards. QUALITY OF EDUCATION: I believe it is important to work with municipalities to take population numbers, both present and projected into consideration, as these trends will affect funding to the school, potential staffing and resources to help our educators deliver the quality of programs they strive for. A balance between effective management of resources and the impact on school staff and programs must be always taken into account." 	"We are privileged in Canada to have an increasingly diverse culture. I believe respecting all religions is important from an ethical and educational standpoint as we can all benefit from respecting and learning from one another. From a fiscal standpoint, I also believe the public educational funding should be equal for all and be focused on providing quality of education to prepare our students for their future academic and employment skills. Therefore, I would support a task force to examine the feasibility of merging Catholic and Public boards to create a secular, non-partisan public system of equal opportunity and funding." In my opinion, part of the follow up for these incidents should also include access to adequate counseling and support for all involved."

Kelly Bairos	"When deciding whether or not to close a school, I believe that there needs to be information provided from several different sources, including, but not limited to, parents, communities, school board and demographic data, senior administration, and research. We need to investigate if a school truly needs to be closed or if a boundary revision (or other alternative) could satisfactorily right-size the school in question and nearby schools – with long- term planning in mind, which also includes working with our municipalities. Fiscal responsibility is important but so are student outcomes therefore all of the available evidence needs to be clearly examined to see what the right choice for our students may be."	"I support the merging of the Catholic and Public boards into One Public System. I believe that many of our current issues, including empty pupil places, bussing, and the teacher shortage, could be rectified if the competition was reduced. More students would be able to attend schools in their communities and long-term planning would be able to be done more efficiently since all students in an area would be attending the same board. This of course would not be without difficulties; aside from the question of the constitution, some things we would need to consider include what staffing requirements there would be at the board level, what to do with the multitude of school buildings, etc."	"This is not an area I have had much experience with but I did recently have a conversation with a parent who noted the importance of this issue and brought it to my attention. In one instance that she mentioned, there was a public statement made about an incident, where in other situations, there was no public mention made. The issue of transparency is a great one – I believe that the board, being funded by public dollars, is accountable to the public and that any violent (or unsafe) incident that puts our students at risk should be shared with the public. As the representatives of TVDSB residents, trustees – and the Chair in particular to represent the Board – should be responsible for reporting back to their constituents. With the limited information that I currently have, I would say that improvement is needed in the way information is communicated to parents and the wider community. There are policies and procedures in place and trustees need to ensure that they are actually implemented and that all those affected are notified with dangerous situations arise."

As a trustee who is responsible for responding to public concerns, I would also make sure that I have information ready about those community supports that are available to residents outside of our schools. I would also promote mental health professional development and training for our frontline staff, especially teachers, but also including principals and other key staff involved on a daily basis with students. For example, there are currently mental health resource packages available for principals that were developed by School Mental Health ASSIST, for which training is to be provided by mental health leads and follow-up provided. These packages were created by school leaders, for school leaders, with support from mental health leaders and implementation coaches.
