Local Collective Bargaining Update

The Local Bargaining Team has tabled significant proposals that form the basis a Positive Workplace Framework.

Local bargaining will resume in September. It is the expectation of ETFO TVTL that the Board will bargain in good faith. A significant number of bargaining dates between the start of the school year and Winter Break have been proposed.

The Local will keep Teachers informed regarding progress at the local bargaining table in a clear, concise and timely manner.

The goal of the ETFO Thames Valley Teacher Local is to negotiate a fair collective agreement, that addresses working condition issues, through free local collective bargaining.

Communication Protocol

Teachers are reminded that the **Communication Protocol** remains in effect **from** Friday, June 30 at 6:00 p.m. **until** Monday, September 4, 2023, at 6:00 p.m.

The Board's **Disconnecting from Work Employee Procedure** came into effect on Thursday June 2, 2022, in compliance with the **Working for Workers Act, 2021**.

Violations of the Communication Protocol and the TVDSB Disconnecting from Work Procedure must be reported to the Local office immediately.

Ontario Labour Relations Board (OLRB) Ruling on PPM 168 and the Early Reading Screener

The recent ruling of the OLRB confirms that current collective agreement language remains active, that the Ford government violated the collective agreement and bargained in bad faith, and that Teacher use of the Early Reading Screener is not mandatory.

Red Cross/Northwest Territories (NWT) Wildfire Relief

The ETFO Provincial Executive approved the following motion:

That ETFO donate \$25,000 to the Canadian Red Cross and match any ETFO Local donations for up to an additional \$25,000, to help aid in the fight against the wildfires in the Northwest Territories, with costs charged to Local Donations, Budget Line 22295 - Disaster Relief Donations.

The Canadian Red Cross is working diligently to help aid relief efforts in areas affected by the raging wildfires in the Northwest Territories.

The NWT has declared a territorial state of emergency in response to out-of-control wildfires. Dangerous fires continue to spread throughout the territory posing a significant threat to many communities and forcing people to evacuate their homes. Smoke from the fires has caused many highways to be impassable, leaving air travel to be the only safe option.

ETFO Provincial will match local donations to the Red Cross up to an additional \$25,000.00.

The ETFO Thames Valley Teacher Local is donating \$3742.00 in support of this relief effort.

Duty of the Local

- Defend the **Collective Agreement** and the rights of Teachers under it.
- Ensure that the provisions of the Occupational Health and Safety Act are enforced.
- Bring to the attention of TVDSB ongoing Teacher concerns, with the expectation that these concerns will be taken seriously and resolved quickly.
- Communicate with Teachers in a clear, concise, and timely manner.
