The *Education Act* was recently amended by the *Better Schools and Student Outcomes Act*, 2023 (the Act) which received Royal Assent on June 8, 2023. A key element of the Act is to ensure effective governance and leadership across all school boards, including clear accountabilities and responsibilities for monitoring the performance of the Director of Education. To support this intent, the Ministry of Education is seeking input on a proposed new regulation that would provide for a clear, consistent and transparent performance appraisal process for Directors of Education.

We are committed to engaging key sector partners to ensure successful implementation. The ministry is inviting input on the development of the proposed new regulation under the *Education Act* on Ontario's Regulatory Registry for public comment by November 2, 2023.
