Current Collective Agreement language, provisions, and past practices are subject to a statutory freeze during the period of central and local collective bargaining bargaining **(Labour Relations Act, 1995, Section 86, Subsection 1)**. Violations of the collective agreement <u>must</u> be reported immediately to the ETFO Local office (519-474-3150).

# Assignment or Appointment of Teachers

All Teachers are reminded that Education Act Regulation 298, Operation of Schools, Section 19, Assignment or Appointment of Teachers states the following:

**19.** (1) In assigning or appointing a teacher to teach in a division or to teach a subject in a school, the principal of the school shall have due regard for the provision of the best possible program and the safety and well-being of the pupils. O. Reg. 183/10, s. 6.

(2) No teacher shall be assigned or appointed to teach except in accordance with the qualifications recorded on his or her certificate of qualification and registration or as otherwise provided in this Regulation. O. Reg. 183/10, s. 6.

Teachers are assigned to teach grades and subjects for which they are qualified. Mutual consent of the Teacher and Principal is required for any assignment outside of qualification.

## Notification and Confirmation of Assignments

Teachers are reminded that Collective Agreement Article L23.20 states the following:

- All assignments will be determined by the Principal.
- A Principal shall provide in writing, by April 15, notification and confirmation of assignment (i.e. subject area and grades) for the following school year to each Teacher.

## Voluntary Surplus Declaration

Teachers are reminded that Collective Agreement Article L24.04 states the following:

- A 1.0 FTE Teacher may voluntarily declare themselves surplus from their school. Parameters are based on staff allocations to schools for the following school year.
- A Teacher must notify their Principal of their intent to voluntarily declare themselves surplus on April 17, by submitting the Voluntary Surplus Declaration form, available in the Employee Portal.

## Lambton-Kent-Middlesex By-election Thursday May 2

Teachers are advised that a by-election has been called in the provincial riding Lambton-Kent-Middlesex. The vacancy was created on October 6, 2023, by the resignation of MPP Monte McNaughton from cabinet and the legislative assembly.

The Board's **Disconnecting from Work Employee Procedure** came into effect on Thursday, June 2 in compliance with the **Working for Workers Act, 2021**.

Violations of the **Communication Protocol** and the **TVDSB Disconnecting from Work Procedure** must be reported to the Local office immediately.

- Defend the **Collective Agreement** and the rights of Teachers under it.
- Ensure that the provisions of the Occupational Health and Safety Act are enforced.
- Bring to the attention of TVDSB ongoing Teacher concerns, with the expectation that these concerns will be taken seriously and resolved quickly.
- Communicate with Teachers in a clear, concise, and timely manner
