#### Bill 124 Remedy

Teachers should be in receipt of the Bill 124 remedy payment. Questions should be directed to TVDSB payroll. The ETFO Thames Valley Teacher Local does not have access to the personal financial information required to address individual questions/concerns regarding payout or specific discrepancies. It has been the position of the Local, from the beginning the Bill 124 remedy process, that Teachers should be provided an itemized breakdown of the remedy payment. Other Boards are providing this information to Teachers. We continue to urge TVDSB to do the same.
